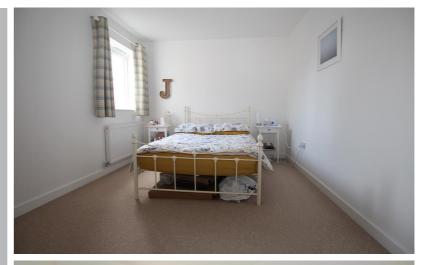




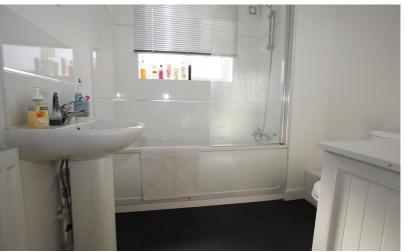
## Agency Fees

Permitted Tenant payments are:-Holding deposit per tenancy - One week's rent Security deposit per tenancy - Five week's rent Unpaid rent - charged at 3% above Bank of England base rate from rent due date until paid in order to pursue non-payment of rent. Early termination of tenancy at tenant's request -Should the tenant wish to terminated their contract early, they shall be liable to the landlord's costs in re-letting the property as well as all rent due under the tenancy until the start of date of the replacement tenancy.
