Offered for sale with no onward chain is this well presented semi detached bungalow occupying a delightful corner plot with well maintained gardens to front, side and rear. The reception hallway, shower room and kitchen have all been extended to increase the size of accommodation on offer which further comprises a lounge/diner and two bedrooms. There is gas fired central heating system via a combination boiler (located in the loft) and upvc double glazing. A driveway to side provides off road parking and access to the detached single garage. The bungalow is particularly well placed for the Swan Island amenities, including a Co-op food store, Post Office, Doctors surgery, Pharmacy, Cafe and Pub.



#### **ENTRANCE HALL**

This extended spacious reception hallway has double glazed window to front and side elevations, central heating radiator and doors leading off to the bedrooms, shower room and lounge/ diner.

#### LOUNGE/DINER

18' 2" x 10' 7" (5.54m x 3.23m) With double glazed bow window overlooking the rear garden, central heating radiator, central feature fireplace and door to :

#### **EXTENDED KITCHEN**

14' 10" x 6' 11" (4.52m x 2.11m) With units at eye and base level providing work surface, storage and appliance space. Single drainer sink unit with mixer tap over, four ring hob, electric oven, plumbing for washing machine, double glazed window at two elevations, central heating radiator, door opening to the rear garden.

#### **BEDROOM ONE**

10' 10" x 7' 10" ( $3.30m \times 2.39m$ ) With double glazed window to the front elevation, central heating radiator, fitted wardrobe.

#### **BEDROOM TWO**

7' 10" x 7' 10" (2.39m x 2.39m) With double glazed window to the front elevation,. Central heating radiator.

#### **EXTENDED SHOWER ROOM**

Comprising a suite in white of wash hand basin with storage beneath, W.C. walk-in shower area housing the mains fed shower. Opaque double glazed window, heated towel rail, tiled floor, part tiled walls. Access to the roof space with pull down loft ladder which houses the central heating boiler.



#### **OUTSIDE**


