Immaculately presented, three-bedroom, semi-detached home, with gardens.

Located in a guiet and established residential area of Loanhead, Midlothian.

Comprises an entrance hallway, living/dining room, kitchen, two double bedrooms, a single bedroom and a family bathroom.

With open views to both aspects, highlights include a modern kitchen and a stylish bathroom, contemporary flooring and lighting.

In addition, there is gas central heating, double glazing and superb storage, including integrated wardrobes and a loft.

A corner plot includes a well-maintained garden, with a lawn, patios, a store shed and established shrubbery, whilst a residential parking area is set adjacent.

A bright, welcoming entrance hall, with storage, is finished with modern, wood-effect flooring and leads into a dual-aspect reception room on the right. Opening onto the rear garden, via French doors, the tastefully presented room offers a spacious, flexible floor plan for both lounge and dining furniture and leads into a kitchen, with separate hall access. The kitchen includes an integrated double oven and a ceramic hob, whilst space is available for a freestanding fridge/freezer, a washing machine and a dryer.

Upstairs, set to either aspect, three flexible bedrooms benefit from built-in wardrobe storage whilst, completing the accommodation, a family bathroom comprises a three-piece suite, a shower-overbath, vanity storage and tiled splash walls.




