# Property Description

Beautifully-presented one bedroom, front-facing flat with a private balcony, set on the second floor of a modern, factored and liftserved apartment block. The property is conveniently located on the bustling Easter Road, to the northeast of Edinburgh city centre.

Comprises: an entrance hall, living room, kitchen, double bedroom, and a bathroom.

Features include uPVC double glazing, gas central heating, integrated storage space, a fitted kitchen with integrated appliances, and TV and telephone points. The building includes a secure entry system and there is ample on-street parking to the front and on the surrounding streets.


The entrance hall has a built-in storage cupboard, the entryphone handset, and wood-effect flooring which continues throughout most rooms. Overlooking the front, and with a small private balcony overlooking Easter Road, the bright and well-proportioned living room features laminate flooring and inset downlights.

With space for dining furniture, the modern fitted kitchen is semiopen plan to the living room and includes contemporary wall and base units, stone-effect worktops, a tiled surround, and a stainless steel sink. Integrated appliances include a gas hob, electric oven, extractor hood, fridge/freezer, dishwasher, and a washing machine.

The double bedroom is also set to the front of the flat, featuring laminate flooring, a built-in wardrobe with sliding mirrored doors, and ample space for further storage and bedroom furniture.

Completing the accommodation, the bathroom is fitted with a white three-piece suite with an electric shower over the bath, and tiled splashwalls.
