Beautifully presented, one-bedroom, third (top) floor flat, forming part of a characterful period red-sandstone tenement. Located close to the open green spaces of Holmlea Park, in the popular Cathcart area, south of Glasgow city centre.

Comprises an entrance hall, living/dining room, kitchen, a double bedroom, and a bathroom.

Highlights include a stylish fitted kitchen with appliances, contemporary flooring, gas central heating and double glazing.

The development includes well-maintained communal stairs, a shared drying green, and a secured entry system.


A welcoming entrance hall, with wood-effect flooring and space for outerwear, affords access throughout the property. A generously sized living room is set to the front, featuring a stunning bay window allowing plentiful natural light, carpeted flooring, a central pendant light, a convenient built-in storage cupboard and space for dining.

Set to the rear, a stylish kitchen is fitted with modern units, wood effect worktops, a sink with a drainer and a metro-tiled surround; with appliances including an integrated oven, gas hob, washing machine; and a freestanding fridge/freezer.

A tastefully finished double bedroom is set to the rear, with light decor, carpeted flooring, twin windows, and a built-in wardrobe with mirrored sliding doors. Completing the accommodation, set internally off the hall, the bathroom is fitted with a three-piece suite including a shower over the bath and tiled splash walls.
