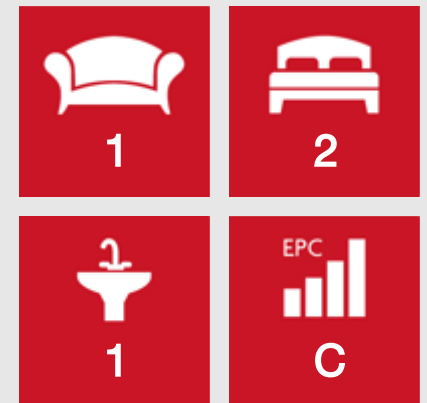






Floorplan
