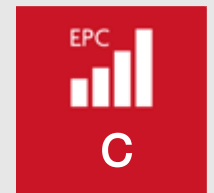
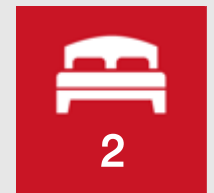

Floorplan

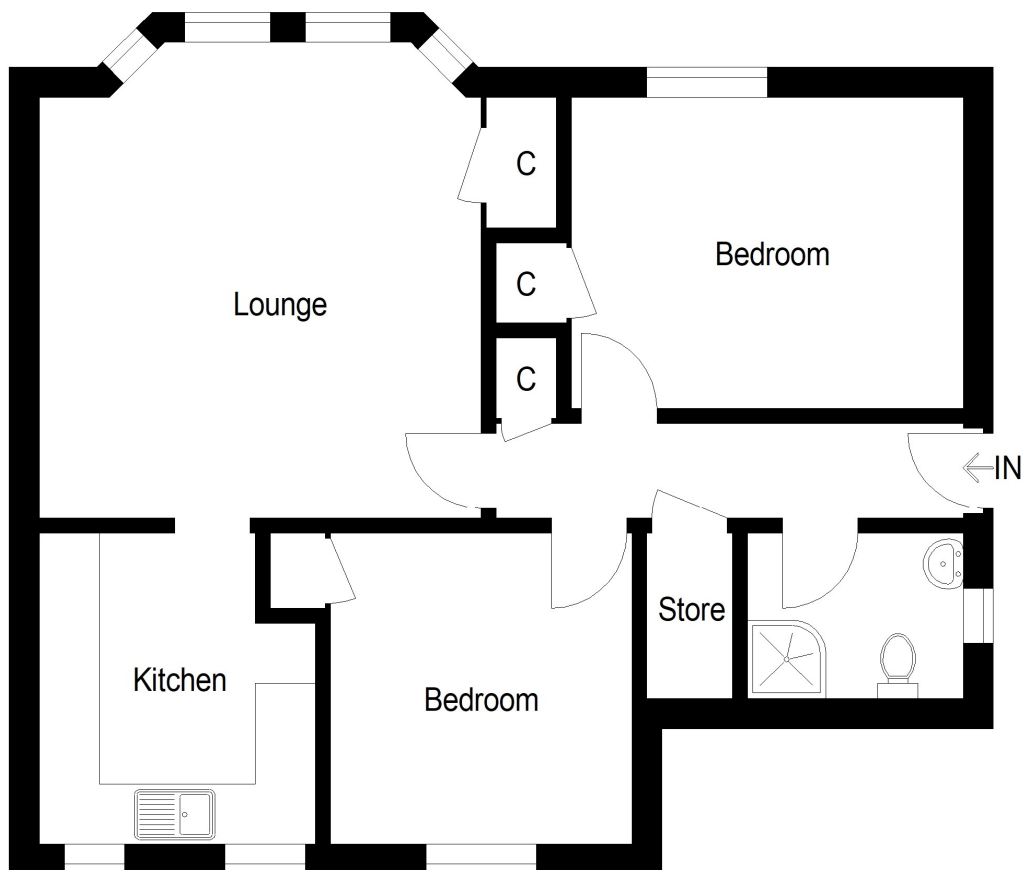
