NOTE 1: The easements granted in Schedule 2 are included in the title only so far as they are legal easements and the landlord had the power to grant the same.

NOTE 2: The rights granted by the registered lease are in part granted over title number BK469937 first registered with possessory title on 28 July 2015 and are consequently not binding on any right or interest adverse to or in derogation of the title of the first registered proprietor of that title.
