Full Details

Overview

The land forms part of Blaenyfan Farm situated in the village of Meinciau, being midway between the towns of Carmarthen and Llanelli.

The land extends to approximately 52.54 acres in total, currently laid to pasture and is contained in several enclosures being accessed off the B4309 roadway, with the majority of the land ranging from being level to gently sloping in nature.

Approximately 34.68 acres of land is suitable for grazing/mowing purposes, with the remainder being heavier land more suited for seasonal grazing only containing rushes and shrub.

We note that there is some fencing on the boundaries of the land which are in need of repair/maintenance, to ensure the land is fully stock proof. There are also pylons crossing the land.
