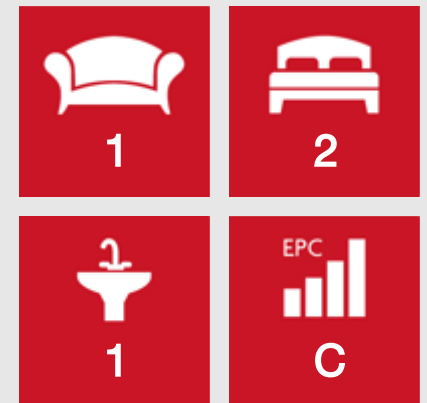




Floorplan
