Summary

End terraced house offering excellent family accommodation over two levels. It benefits from a very large garden (including extra ground purchased from the council), and is finished in very good order throughout. Internally, the accommodation comprises: hall; dual aspect sitting room; extended kitchen; family room extension; dining room; box room / study; and upstairs: master bedroom with cupboard and en suite shower room: a second double bedroom with built in wardrobes and cupboard; a third double with storage; plus a family bathroom (with electric shower over bath). The property has gas central heating (combi boiler) and double glazing. Overall, it is an attractive large family home with paved rear garden with greenhouse and shed.





















Floorplan
