Comprises an entrance hall and stairs, an upper hall, living room, kitchen, two double bedrooms, and a bathroom.


Highlights include a fitted kitchen, a stylish modern bathroom suite, gas central heating and double glazing.

Adjacent to the lounge, the well-proportioned kitchen boasts fitted wall and base units, stone-effect worktops, a tiled surround, a sink with a drainer, and ample space for freestanding appliances.

The main bedroom offers plenty of room for freestanding furniture and is tastefully finished with carpeted flooring, a central light fitting, a wall-mounted TV point, and built-in storage for added convenience. A second good-sized bedroom, located to the rear of the property, features two built-in mirrored wardrobes, providing superb storage provision. Completing the accommodation, a stylish bathroom is fitted with a modern three-piece suite, including a shower over the bath, ceiling-height tiled splash walls, and a ladder-style radiator.


Area Description
