Property Description

Beautifully-presented and spacious, one-bedroom, dual-aspect flat on the second floor of a modern, factored conversion of the Caledonian Distillery. Located in a residential development in Edinburgh's Dalry district, west of the city centre.

Comprises an entrance hall, living/dining room, kitchen, double bedroom and a bathroom.

Features include generous room sizes, a fitted kitchen with appliances, double glazing, gas central heating, storage space, a secure entry system and TV and telephone points. Externally, there is ample space in the residents car park, and a wellmaintained communal courtyard and grounds.

The entrance hall which has a small storage cupboard as you walk in provides access to each room within the property. Set to the front, the living room has wood effect flooring extending from the hall, a central light fitting, a Juliet balcony and ample space for freestanding living/dining furniture.


Open plan to the living room, the kitchen is fitted with modern units and stone effect worktops, a tiled surround, a stainless steel sink with drainer, an integrated oven, and an electric hob with canopy above. Appliances include a fridge/freezer, integrated dishwasher and washing machine.

The generously sized bedroom has a built-in wardrobe, carpeted flooring and a pendant light fitting. Completing the accommodation, the modern bathroom is fitted with a three-piece suite with a mains mixer shower over the bath, tiled splash walls and tiled flooring.
