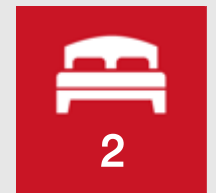
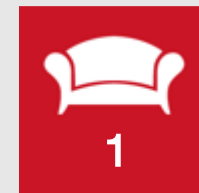

Summary

This is a newly created main door lower ground-floor apartment situated on the westmost elevation of 17-19 King Street accessed via a private staircase for the street level, it has a good level of privacy from passing pedestrian footfall. The apartment has been fully developed and offers 2 bedrooms a contemporarily designed open living dining and kitchen, and a bathroom with a separate shower cubicle. 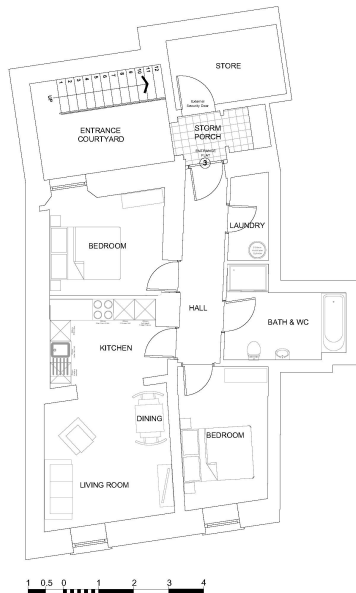
