## **Property Description**

Bright and well-presented, one bedroom, dual-aspect flat, set on the first floor of a traditional block. The property is set on a quiet residential street and is located in the rural town of Maybole, to the south of Ayr.

Comprises: an entrance hall, living room, kitchen, a double bedroom, and a bathroom.

Features include uPVC double glazing, gas central heating, integral storage space and telephone points. Externally, there is a private garden plot and a shared drying area to the rear, with ample on-street parking to the front.

The carpeted entrance hall serves each room within the property, and offers a storage cupboard and space for outerwear. Set to the front, the light and airy living room features carpeted flooring, cornice-work, a storage cupboard, and offers a view over countryside and fields.

Set to the rear, the modern kitchen is fitted with contemporary wall and base units, solid wood worktops and a ceramic sink, with integrated appliances including a ceramic hob with a stainless steel backsplash, an oven and extractor hood, with space and plumbing for freestanding white goods.


The generously sized double bedroom, which has previously been used as the living room, features wall mounted lighting, carpeting, cornice-work, and a recessed window affording plenty of natural light.

Completing the accommodation and set internally off the hall, the bathroom is fitted with a contemporary white three-piece suite with an electric shower over the bath, tiled splash walls and a wood-effect vinyl floor.
