Location

Situated in the village of Carway, centrally located for Llanelli, Carmarthen and the Carmarthen Bay Coastline. The village has hall, football club, Ffoslas Horse Racing course and Glynhir golf club nearby. The County and Market Town of Carmarthen is 11 miles with traditional and national retailers, schools, bus and mainline train station, leisure centre, Lyric Theater and cinema etc. Llanelli Town is 7 miles approx. offering similar facilities. Burry Port Harbour along with 2 great golf courses at Ashburnham & Machynys is 7 miles. Pembrey Country Park is 6 miles with large sandy beach, dry ski slope, enclosed cycle track and woodland walks being some of the attractions within. The ancient town of Kidwelly well known for its picturesque Normandy castle, lovely eateries, etc. Mainline train station.

Continue on and enter the village and the plot will be found on the right hand side shown by a Morgan and Davies For Sale Board before the village hall.
