Bright and well presented, two-bedroom, south-facing flat with a private garden plot, set on the second (top) floor of an established residential development. The property is located in the popular Craigentinny area, east of Edinburgh city centre.

Comprises: an entrance hallway, living/dining room, kitchen, two double bedrooms, and a bathroom.

With light modern decor throughout, features include well proportioned room sizes, a modern kitchen, bedroom wardrobes, and gas central heating (new boiler fitted in 2020 with a 10-year warranty).

In addition, there is a secured entry system, a shared drying green, and an enclosed private garden plot with a store shed to the rear.

The hallway gives access throughout, and has a built-in store cupboard, carpeted flooring, and the secured entry handset. Southerly-facing to the front, the dual-aspect living room has space for both lounge and dining furniture, and features carpeted flooring, coving and a feature fireplace.

The kitchen is rear-facing off the lounge, and has modern fitted units, wood-effect worktops, stainless steel sink, a tiled surround, washing machine, and an electric cooker unit.

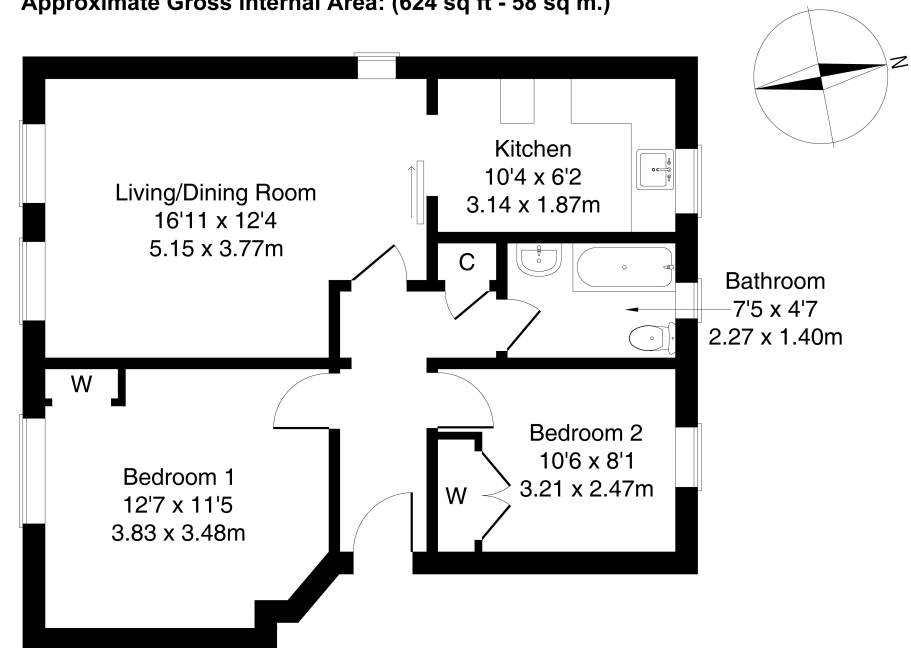

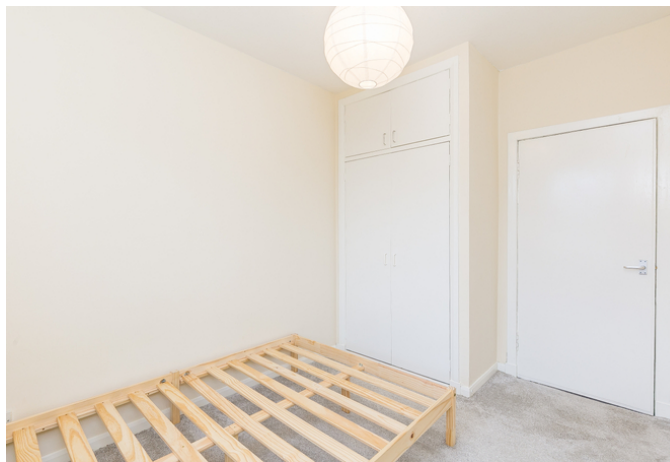
